CONTRACT

The Contract for Transportation Services (vehicle rental with driver) in Jeju for Official Use of the Embassy during the Jeju Forum 2026 on 25 to 26 June 2026 ("Contract") is entered into between the **EMBASSY OF THE REPUBLIC OF THE PHILIPPINES** in Seoul ("*Embassy*"), with its office at 80 Hoenamu-ro, Yongsan-gu, Seoul 04346, represented by Ambassador Bernadette Therese C. Fernandez, and **CENTUM NEW JEJU TRAVEL** ("*Company*") with its office at 42642 Noyeon-ro, Jeju-si represented by Mr. Cho Dae Won, and jointly known as "Parties".

I. Scope of Work

The Embassy shall engage the services of the Company for the Philippine Embassy delegation (2 *pax*) attending Jeju Forum 2026 from 25 to 26 June 2026 (inclusive of travel time). This will also include pick-up and drop-off during the arrival and departure of the delegation.

III. Expected Deliverables

- a. The Company shall ensure that the vehicle assigned to the Embassy is in excellent condition. However, if the vehicle breaks down, the Company will arrange for its immediate replacement.
- b. The assigned vehicle shall include a driver who can preferably speak the English language.
- c. The assigned vehicle should be of the year 2020 and onwards.
- d. The Embassy is not liable for the maintenance of the company's vehicles. The Company shall be responsible for the maintenance of its vehicle.

IV. Vehicle Specifications

Based on the number of people, the Embassy will need one (1) van to comfortably seat the Philippine Embassy officials (2 persons).

V. Vehicle Rate

As agreed, the rate for the transportation services is **Nine Hundred Fifty Thousand Korean Won (KRW 950,000)**, calculated based on the itinerary (Section II).

VI. Terms of Payment

Payment shall be made within ten (10) days after fulfillment of the contract and receipt of the invoice. The Embassy shall deposit the payment to the Company's bank account with the following details:
