Terms of Reference

The Philippine Embassy intends to engage a reputable supplier for professional banquet services for the Ramon Magsaysay Awards Foundation (RMAF) Laureate and Reunion on 22 April 2025.

I. Background

In celebration of the 25th anniversary of the Emergent Leadership Award from the Ramon Magsaysay Awards Foundation (RMAF) and in recognition of the 75th anniversary of diplomatic relations between the Philippines and Korea, the Embassy is organizing a laureate reunion, exhibition and reception of the RMAF Laureates from ROK who have excelled in the fields of good health and well-being, peace, justice and strong institutions, reduced inequalities, gender equality, and quality education on 22 April 2025.

The event shall be attended by Magsaysay Laureates in ROK, members of the diplomatic corps, MOFA officials, and supporters.

II. Scope of Work

The Supplier shall undertake the following:

- A. Provide a suitable venue, including the necessary furniture, that can accommodate eighty (80) persons and ensure the delivery of efficient and professional event management services.
- B. Provide a customized menu for a standing cocktail buffet
- C. Provide audiovisual equipment (e.g. screen and projector, microphones, etc.), and parking for guests
